- 1. <u>REQUEST your ballot</u> the sooner the better to assist counties in managing the volume. <u>ASAP or by May 19, 2020</u>
- 2. WAIT for ballot to arrive in the mail
- 3. VOTE & RETURN your absentee ballot postage prepaid to the Clearwater County Clerk Ballots must be received by 8:00 pm on June 2, 2020 in order to be counted.

Due to the current state of emergency related to the novel coronavirus, the May 19, 2020 Primary Election will be held by absentee ballot ONLY.

- 1. **REQUEST**: To receive a ballot for the May 19, 2020 Election, please complete the form below and return it to your county clerk *no later than Tuesday, May 19, 2020*. You may also request an absentee ballot online at Idahovotes.gov.
- 2. WAIT: It may take 10-14 days from receipt to process and return your absentee ballot to you by mail.
- 3. VOTE & RETURN: Your voted ballot must be returned to your local Clerk/Elections office by June 2, 2020 to be counted.

You must be registered to request an absentee ballot. You may register to vote at Idahovotes.gov or through your county clerk.

Your party affiliation will affect your ballot choice for this primary election. Please see the ballot options for party affiliations and unaffiliated voters below. You may view your party affiliation at Idahovotes.gov.
