

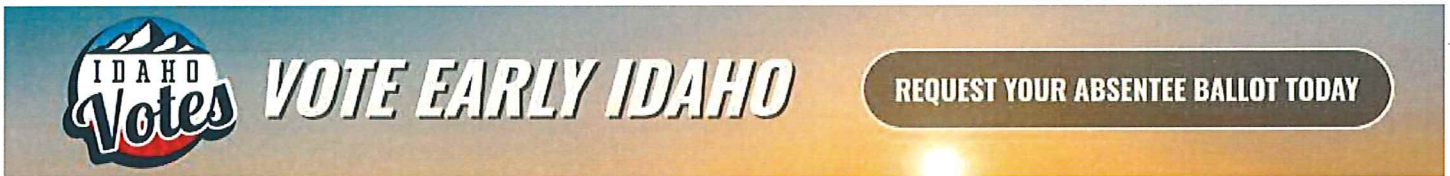

Given the growing number of coronavirus cases in Idaho, it simply was not safe for voters, election workers or the larger community to hold in-person voting for the May primary. Having Idahoans request a ballot and vote at home will protect the health of Idahoans, slow the spread of COVID-19, allow the election to move forward as scheduled and ensure everyone can still exercise their right to vote.

“Voting Absentee is as easy as 1, 2, and 3.”

1. **REQUEST your ballot** – the sooner the better to assist counties in managing the volume.
ASAP or by May 19, 2020
2. **WAIT** for ballot to arrive in the mail
3. **VOTE & RETURN** your absentee ballot postage prepaid to the Clearwater County Clerk
Ballots must be received by 8:00 pm on June 2, 2020 in order to be counted.

Due to the current state of emergency related to the novel coronavirus, the May 19, 2020 Primary Election will be held by absentee ballot ONLY.

- REQUEST:** To receive a ballot for the May 19, 2020 Election, please complete the form below and return it to your county clerk *no later than Tuesday, May 19, 2020*. You may also request an absentee ballot online at Idahovotes.gov.
- WAIT:** It may take **10-14 days from receipt to process and return** your absentee ballot to you by mail.
- VOTE & RETURN:** Your voted ballot must be returned to your local Clerk/Elections office **by June 2, 2020 to be counted.**

You must be registered to request an absentee ballot. You may register to vote at Idahovotes.gov or through your county clerk.

Your party affiliation will affect your ballot choice for this primary election. Please see the ballot options for party affiliations and unaffiliated voters below. You may view your party affiliation at Idahovotes.gov.
